RULES AND REGULATIONS

- 1) NO FIGHTING ANYWHERE INSIDE OR OUTSIDE THE FACILITY.
- 2) NO PHYSICAL OR VERBAL ABUSE TO THE STAFF
- 3) ALL PERSONAL DECORATIONS, CENTERPIECES, TABLES, GIFTS, ETC-

MUST BE REMOVED BY THE CLIENT IMMEDIATELY FOLLOWING THE EVENT.

- 4) THE CLIENT, AND OR VENDORS, WILL BE RESPONSIBLE FOR THE LOAD IN AND OUT, SET UP AND TEAR DOWN OF ALL PERSONAL RENTAL EQUIPMENT.
- 5) NOTHING MAY BE LEFT AT ACQUAINT GATHERING AFTER THE EVENT, INCLUDING, BUT NOT LIMITED TO: ALCOHOL, KEGS, CATERING, RENTAL EQUIPMENT, RENTAL CHAIRS, RENTAL LINENS, ETC. ACQUAINT GATHERING IS NOT RESPONSIBLE FOR THIS TASK.
- 6) CLIENT IS DEEMED RESPONSIBLE FOR THE HIRING OF BARTENDER STAFF AND OR SECURITY GUARDS IF DEEMED NECESSARY.
- 7) CURFEW AT VENUE IS MIDNIGHT: ALL YOUR BELONGINGS, ETC MUST BE OUT OF THE BUILDING BY THIS TIME.
- 8) NO ALCOHOL WILL BE SOLD IN FACILITY WITHOUT A POSTED LIQUOR OR CATERERS LICENSE THROUGHOUT THE EVENT.
- 9) NO ALCOHOL CAN BE SERVED TO MINORS!!! ACQUAINT GATHERING RESERVES THE RIGHT TO I.D. ANYONE ON THE PREMISES.
- 10) CLIENT IS SOLELY RESPONSIBLE FOR THE SOBRIETY OF THEMSELVES, AND THEIR GUESTS, STAFF OR BARTENDERS HIRED HAVE THE RIGHT TO DENY ALCOHOL OR CUT OFF ALCOHOL TO ANY GUESTS WHO IS THOUGHT TO BE OVER THE LIMIT, FOR THEIR OWN SAFTEY.
- 11) ANY ALCOHOL SERVED IN THE FACILITY MUST REMAIN INSIDE THE BUILDING.
- 12) NO GLASSWARE OR BOTTLES ALLOWED ON DANCE FLOOR. ACQUAINT GATHERING WILL NOT BE HELD RESPONSIBLE FOR GUESTS WITH INJURIES DUE TO BROKEN GLASS OR SLIPS FROM SPILLS ON THE DANCE FLOOR OR ON THE PREMISES, DUE TO NON-COMPLIANCE.
- 13) THE CLIENT IS RESPONSIBLE FOR ALL OF THE VENDORS THEY BRING INTO ACQUAINT GATHERING, AND SHOULD MAKE SURE ALL RULES ARE FOLLOWED BY THE VENDORS THE CLIENT HAS HIRED.
- 14) THE CLIENT HAS AGREED TO VACATE THE PREMISES BY MIDNIGHT ON THE DAY OF THE EVENT, TO GET DECORATIONS, GIFTS, DJ'S VENDORS, AND PERSONAL ITEMS REMOVED FROM ACQUAINT GATHERING NO LATER THAN MIDNIGHT ON DAY OF EVENT.

- 15) ACQUAINT GATHERING IS NOT RESPONSIBLE FOR ANY LOST, STOLEN, OR DAMAGED ITEMS BELONGING TO THE CLIENTS, CLIENTS FAMILY, GUESTS, OR CLIENTS VENDORS.
- 16) ACQUAINT GATHERING STAFF HAS THE RIGHT TO REMOVE ANYONE OR GROUP THAT DOES NOT ABIDE BY THE RULES AND REGULATIONS WRITTEN IN THIS CONTRACT.
- 17) ACQUAINT GATHERING HAS THE RIGHT TO STOP THE EVENT AT ANY TIME IF THE CLIENT, GUESTS, OR VENDORS THE CLIENT HAS HIRED ARE NOT ABIDING BY THE WRITTEN RULES AND REGULATIONS OR ARE DAMAGING ACQUAINT GATHERING PROPERTY.
- 18) VENUE, BRIDAL SUITE, GROOMS ROOM ARE REQUIRED TO BE LEFT IN THE CONDITION IN WHICH WAS RECEIVED(MINUS MOPPING, SPILLS, OR VACUUMING)
- 19) NO COOKING IS ALLOWED ON PREMISES.
- 20) IN ADDITION TO THE RENTAL CHARGE, THERE WILL BE AN ADDITIONAL _______REFUNDABLE DAMAGE DEPOSIT AT ACQUAINT GATHERING'S DISCRETION. IF THE CONDITIONS ARE STRICTLY FOLLOWED, WITH NO DAMAGE, LOSS OF EXCESSIVE MAN HOURS INVOLVED FOR ADDITIONAL CLEAN UP, THE DEPOSIT SHALL BE RETURNED WITHIN 5 BUSINESS DAYS FOLLOWING YOUR EVENT. TO THE EXTENT THAT THE DAMAGE DEPOSIT IS NOT ADEQUATE TO COVER DAMAGES, LOSS OR CLEAN UP TO ACQUAINT GATHERING, THE CLIENT AGREES TO PAY THE EXCESS AMOUNT WITHIN FIVE DAYS FOLLOWING THE EVENT.
- 21) FAILURE TO COMPLY WITH ANY OF THESE RULES OR REGULATIONS WILL FORFEIT CLIENTS DAMAGE DEPOSIT IN FULL.
- 22) YOUR CHOICE OF CATERING IS ALLOWED.
- 23) NO SMOKING IS ALLOWED.
