The Greene County Quorum Court held its regular meeting Monday, June 17, 2024, in the Circuit Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. Justice Robby Glasco made a motion and Justice Michele Boling seconded to suspend the rules to put it on its 3<sup>rd</sup> reading, title only. The motion carried, and the Ordinance was read, title only, by Attorney Kimberly Dale. Justice Reeves made a motion and Justice Keeling seconded to accept the Ordinance on its 3<sup>rd</sup> reading, title only. The motion carried. The Ordinance was adopted as read. Justice Roberts made a motion and Justice Allen Davis seconded to add an emergency clause. The Emergency Clause was adopted as read.

The Ordinance was read, title only, by Attorney Kimberly Dale. Justice Phillip Keeling made a motion and Justice Dean Wooldridge seconded to accept the Ordinance as Read. The motion carried.
