AMENDED MINUTES**

The Greene County Quorum Court held its regular meeting Monday, March 18, 2024, in the District Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. The following were in attendance: Justices Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves, and Ronnie Roberts. Justices Sherma Dicus and Clint Harris were not present.

The meeting began with the Pledge of Allegiance led by County Judge Rusty McMillon and followed by a prayer from Justice Robby Glasco.
