The motion carried. The Resolution was read by Attorney Kimberly Dale. Justice Jonathon Davis made a motion and Justice Robby Glasco seconded to approve. Justices Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge and Kirk Brinkley voted in favor. Justices Marc Reeves and Ronnie Roberts opposed. The motion carried. The Resolution was adopted as read.

Justice Jonathon Davis made a motion and Justice Ronnie Roberts seconded to amend by removing section 3 from the Appropriation Ordinance titled "AN APPROPRIATION ORDINANCE TO AMEND GREENE COUNTY ORDINANCE 2024-27". All in favor, the motion to remove section 3 was approved.

Justice Marc Reeves made a motion and Jonathon Davis seconded to suspend the rules and put an Ordinance titled "AN APPROPRIATION ORDINANCE TO AMEND GREENE COUNTY ORDINANCES 2024-7 (SECTION 3 ONLY)" on its first reading by title only. The Ordinance was read, title only, by Attorney Kimberly Dale. Justice Marc Reeves made a motion and Justice Ronnie Roberts seconded to accept the Ordinance as read. Justices Robby Glasco, Bill McCartney, Michele Boling, Allen Davis, Marc Reeves, and Ronnie Roberts voted in favor. Justices Jonathon Davis, Phillip Keeling, Dean Wooldridge and Kirk Brinkley opposed. The ordinance did not pass with 6 for and 4 against. Justice Ronnie Roberts made a motion and Justice Marc Reeves seconded at that time to table Section 3 of this Appropriation Ordinance.
