

**GREENE COUNTY QUORUM COURT
GREENE COUNTY COURTHOUSE
OCTOBER 20, 2025
MINUTES**

The Greene County Quorum Court held its regular meeting Monday, October 20, 2025. The meeting began outside of Greene County Courthouse with the Pledge of Allegiance led by County Judge Rusty McMillon and followed by a special proclamation titled, "HONORING THE GREENE COUNTY RESCUE SQUAD AND FOUNDER, BUTCH HEATH, FOR FORTY-TWO YEARS OF DEDICATED SERVICE." The proclamation was read by County Judge Rusty McMillon. Justice Kirk Brinkley made a motion and Justice Marc Reeves seconded to accept the proclamation, "HONORING THE GREENE COUNTY RESCUE SQUAD AND FOUNDER, BUTCH HEATH, FOR FORTY-TWO YEARS OF DEDICATED SERVICE", as read. All in favor, none opposed.

Following the ceremony the meeting continued in the Circuit Courtroom on the second floor of the Greene County Courthouse with Greene County Judge Rusty McMillon presiding. A prayer was led by Justice Ronnie Roberts.

Justice Marc Reeves made a motion and Dean Wooldridge seconded to put an Ordinance titled **“AN ORDINANCE MODIFYING THE TERM LIMITS AND BOARD SUCCESSION AND EMENDING ORDINANCE NO. 2025-11, 1992-8, AND 2013-10, AND FOR THE GREENE COUNTY HUMAN SERVICES FACILITIES BOARD, AND FOR OTHER MATTERS PERTAINING THERETO”**, on its first reading. The Ordinance was read in its entirety by Attorney Kimberly Dale. Justice Dean Wooldridge made a motion and Justice Marc Reeves seconded to accept the Ordinance as read. The motion carried. Justice Marc Reeves made a motion and Justice Phillip Keeling seconded to suspend the rules and put it on its 2nd reading by title only. The motion carried, and the Ordinance was read, title only, by Attorney Kimberly Dale. Justice Allen Davis made a motion and Justice Sherma Dicus seconded to accept the 2nd reading, title only. The motion carried. Justice Sherma Dicus made a motion and Justice Ronnie Roberts seconded to suspend the rules and put it on its 3rd and final reading, by title only. The motion carried, and the Ordinance was read, title only, by Attorney Kimberly Dale. Justice Dean Wooldridge made a motion and Justice Marc Reeves seconded to accept the 3rd and final reading. All in favor, none opposed, and the motion carried. The Ordinance was adopted as read.

NEW BUSINESS –

Justice Marc Reeves made a motion and Justice Bill McCartney seconded the removal of an item from inventory, presented by the County Judge. Item was a Canon Image Runner 5070. Vote of acclamation.

Justice Phillip Keeling made a motion and Justice Sherma Dicus seconded to read a Resolution titled **“A RESOLUTION TO APPOINT CHARLOTTE GUNN TO THE GREENE COUNTY LIBRARY BOARD”** The motion carried. The Resolution was read by Attorney Kimberly Dale. Justice Marc Reeves made a motion and Justice Phillip Keeling seconded to approve. All in favor, none opposed. The motion carried. The Resolution was adopted as read.

Justice Marc Reeves made a motion and Justice Robby Glasco seconded to suspend the rules and put an Ordinance titled **"AN APPROPRIATION ORDINANCE TO AMEND GREENE COUNTY ORDINANCES 2024-27"** on its first reading by title only. The Ordinance was read, title only, by Attorney Kimberly Dale. Justice Sherma Dicus made a motion and Justice Marc Reeves seconded to accept the Ordinance as Read. The motion carried.

PUBLIC COMMENTS (FOR ITEMS NOT ON THE AGENDA) – None.

Justice Marc Reeves made a motion and Justice Kirk Brinkley seconded to adjourn. The motion carried and the meeting was adjourned.
