The Greene County Quorum Court held its regular meeting Monday, March 16, 2026, in the Circuit Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. 
Justice Marc Reeves had to step out due to emergency and was not present nor voted on the rest of the agenda items from this point forward.
