The Greene County Quorum Court held its regular meeting Monday, June 15, 2026, in the Circuit Courtroom on the second floor of the Greene County Courthouse with Justice Jonathon Davis. The following were in attendance: Justices Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves, Ronnie Roberts, and Kirk Brinkley. Justice Sherma Dicus were absent.

The meeting began with the Pledge of Allegiance led by Justice Jonathon Davis and followed by a prayer from Justice Phillip Keeling.

Justice Ronnie Roberts made a motion to vote for Justice Jonathon Davis to preside over meeting in County Judge Rusty McMillon's absence. The vote was affirmed, all in favor.

Justice Phillip Keeling made a motion and Justice Marc Reeves seconded to accept the minutes of the May 18, 2026, meeting. The minutes were accepted.

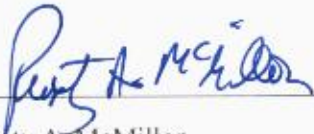
